

## PAVAN K VARMA: THE MAN OF ALL SEASONS

Meet our man next door with many hues, each one no less bright than the other. Equipped with diplomatic, political, and literary experience, he is as conspicuous by his presence in cultural events as he is in television debates, high level conferences and seminars. In conversation, he can keep you engaged for hours together without making you feel boredom, switching from one topic to another with ease.

Who is he? He is none other than **Pavan K Varma** – a diplomat, politician, author and an excellent orator and a passionate lover of poetry.

Pavan K. Varma was born in Nagpur but was brought up in Delhi. He is a graduate in history from St. Stephen's Collage and a law graduate from the Faculty of Law, University of Delhi. Pavan is a resident of Vasant Vihar residing in his own house which his mother built in early '70s. Recalling those good old days he says, "Those were the days when taxi drivers would refuse to go beyond Moti Bagh. I never forget a scooter-walla turning to me and saying, "kahan jangal mein le ja rahe hein?"

Pavan joined the Indian Foreign Service in 1976. During his career, he held several prestigious appointments including press secretary to the President of India, spokesman of the Ministry of External Affairs, and not the least, the ambassador of India to Bhutan and Cyprus.

He has written several best selling books including Krishna. His first book on a contemporary subject was The Great Indian Middle Class, also published in French. His other books include Being Indian, Becoming Indian, Adi Shankaracharya: Hinduism's Greatest Thinker, and Tulsidas's Ramcharitmanas. Not content with just being an author he took to translation of poetries of Kaifi Azmi, Atal Bihari Vajpayee and Gulzar.

Pavan is a recipient of several prestigious honours and awards including the Honorary Doctoral Degree for his contribution to the fields of diplomacy, literature, culture, and aesthetics from the University of Indianapolis and Bhutan's highest civilian award Druk Thuksey conferred by His Majesty the King of Bhutan. Incidentally, he is the only Indian diplomat who has received this honour while in service.

His columns regularly appear in The Times of India, The Hindustan Times, The Asian Age, Deccan Chronicle, Lokmat, Dainik Bhaskar and First Post, and several other publications. His dynamic personality continues to remain a familiar face on television channels.

Pavan Verma is now in politics, where till recently he was a Member of Parliament (Rajya Sabha) and earlier, Adviser to the Chief Minister of Bihar with cabinet rank.

Does he call himself as Delhiite being a resident of Vasant Vihar? "I do not know if the city belongs to me, but I do know that I have no other place I can call my home. Even though I was not born in this city, I grew up in it. It

provided the background to my childhood, and the foundation on which I structured my later life. It is the city where I met my wife. It is the city where my children were born", says Pavan.

Pavan has three children, a son and two daughters. The son, Vedanta, is a successful lawyer, with his own law firm; his daughter, Batasha, who also stays in Vasant Vihar, is married to food consultant, Siddhartha Mathur, owner of Khoya mithai, and a partner in the restaurant chain, Smoke House. His eldest daughter, Manvi, is a successful clinical psychologist in USA.

Pavan attributes his success story to his wife Renuka Varma, who is a painter and educationist. She has always been by his side bringing up their three children and fulfilling her family obligations and the responsibilities as diplomat's wife.

What has been his best phase of life and the best moment? "It is yet to come", he says with a mischievous wink and smile on his face.


## **DIWALI DECORATIONS**

## ANNUAL GENERAL BODY MEETING: VVWA

Vasant Vihar Welfare Association held its 51st Annual General Body Meeting at the historic Kalyan Kendra, Paschimi Marg, New Delhi on November 13, 2022. The meeting began on time with the observance of two minutes silence in the memory of the members of the Association, who had left for their heavenly abode during the period 2021-22, followed by a presentation about the previous year by the Secretary of the Association, Ms. Mridula Murgai.

She highlighted the various projects and

activities, with special reference to the special efforts put in by the VVWA management during the unprecedented water crisis experienced this summer.

She concluded her presentation saying, "Our main role is that of liaison between the authorities and our residents. We are the conduit and the intermediary between all of you and departments such as the Delhi Jal Board, the PWD, the MCD, the sanitation department and the BSES, to name just a few. It sounds easier than

it really is. Most of you are familiar with the lack of response from bureaucracy and government organisations!



We deal with it all through the day. We call, we cajole, occasionally we shout at them, and somehow try to get them to respond and do the needful".

"In the end I would like to say a few words that concern our team and specially the five office members who are presently on the stage in front of you. We are all volunteers who have been elected for two successive terms by you. We are accessible to you all the time; we are open to constructive criticism and conversation. But, lately in public we have been demeaned and denigrated with WhatsApp posts and messages which have moved beyond the rules of civility.

The MC team has been called terms such as kachra, termites, parasites, and even a 'kitty party'. This is the first time that I have heard the term kitty party being used as an insult! Surely this is not how a civilised society deals with issues between its members. We would like all of you to think about this and join us in sending out a message that this is not acceptable. Instead, let's also send out a message of goodwill and of working together rather than of being insulting and disparaging".



#### "Please do introspect about this."

The Annual Reports were then presented by the President, Mr. Gurpreet Bindra. After he offered the necessary clarifications, the Annual Report was adopted by the General Body.

Thereafter the audited accounts/audited report of the Association for the year ended March 31, 2022 were adopted by the General Body after which the various resolutions moved by VVWA were taken up for approval by the General Body.

#### The General Body adopted the following resolutions:

 The term of the Managing Committee will be increased from two years to three years as and when the next Managing Committee takes over after the next elections.

- All members who will attain or have attained the age of 80 years during the financial year for which subscriptions are to be paid, will be exempted from the payment of the annual subscription. However, they would be required to pay the one-time admission fee, when they seek admission.
- Anyone who has defaulted in his subscription would not be allowed to contest the elections, as and when they are held. Any 'defaulter' will not be entitled to cast his/her vote at the elections as and when they are held. The cut-off date for payment will be one day prior to the date of the election to the Managing Committee.

• The General Body will elect every three years the following office bearers: President, Vice President, Director (Administration), Director (Operation) and Director (Finance). Two members from each block viz A, B, C, D, E and F, to be elected only by the members (who have paid their dues) residing in the respective Blocks.

## KHAIRATI LAL BATRA – ONE OF VASANT VIHAR'S FIRST RESIDENTS

In 1973 when Vasant Vihar was just about shaping up as a colony and there were only a few houses coming up, Shri Khairati Lal Batra started a grocery store in the C block Market. For over half a century Mr Batra, a senior citizen of our colony, has been witness to its development.

Post his family moving to Rohtak after 1947, young Khairati Lal came to Delhi with his father. In 1973, when the market stores were being auctioned, Mr Batra bought one of them. And the rest is history.

My conversation with him covered a span of many decades:

## Q – What was Vasant Vihar like when you first started your grocery store here?

 $Mr \ B$  – It was mostly jungle. We could see a few faint lights at night, some diya ki roshni, as full electrification had not yet happened. There was a village here and the rest of it was simply bushes and trees. We could see right up to A

block and beyond. Roads were not properly formed, and facilities were practically non-existent. But the markets were being developed and auctioned.

#### Q - Did you have many customers?

**Mr B** – There were a few houses that had come up and a few were being constructed and they came to buy their groceries.

#### Q – What was your relationship with them?

**Mr B** – We had a very personal relationship. Residents would drop by and pick up stuff, or tell me and I would go and deliver personally. Whenever we bumped into each other, we would always greet each other, there was such a personal connection! So much so that they and their children still come to me!

#### Q-What kind of changes have you seen over these 4 decades of Vasant Vihar?

**Mr B –** Well, the good side is that facilities have expanded, roads have become so good, connectivity to the rest of the city has become so much easier. On the other hand, people have become isolated and uncaring now. Residents do not come themselves – they simply order on the phone or send their staff/drivers. People have become distanced and now it is purely commerce. Earlier. people participated in your life – your dukh-sukh. Now there is no such thing; except for a few. the personal touch is gone.

And the traffic has become terrible – I see people's drivers fighting over space and think back on easier times when we were all polite to each other.

#### Q – Your sons are now handling your business. Are they satisfied?

**Mr B** – They are happy to follow in my footsteps, but I don't think my grandchildren will want to follow my footsteps.

Well, it will be our loss!

## THE SANDWICHED GENERATION

"During my childhood, I was afraid of my parents. As I grew older my teachers bossed me. Once I got married, I was afraid of my in-laws and my husband. Then my children took over and again I was the subdued one. Now my daughter-in-law has arrived and even though she is a lovely person, I am afraid to say anything to her because she might get offended."

Does this refrain sound familiar? Does it touch a chord somewhere - or do you mock it and wonder which spineless woman is talking in this fashion?


You will be surprised at how many women feel that life has somehow passed them by. Somewhere their individuality has been submerged in the sea of family and obligations. This is the generation of women who are "the sandwiched generation."

Most of these women were born between 1945 and 1960. Some of them were children when freedom was achieved and were among the first few who were a part of the education system of Free India.

Many of them studied in colleges and completed their bachelor's Degrees. Few sought careers - and those who did found themselves limited to medicine, teaching, or law. Marriage was the ultimate goal for the majority of these women, and by the time they completed college education - the process of arranged marriages had begun. Social life before marriage was limited to films, an occasional group outing and very few mixed parties.

There was a sea-change in their lives after marriage. Suddenly, they were asked to play the roles of housewives, daughters-in-law, sisters-in-law, and wives. Most of them were completely unprepared and definitely unqualified for this. But soon they learnt how to excel in all the roles they played. Their homes were immaculate, their children were nurtured and cherished, and their husbands were given unflinching devotion and support.

But as they grew older they watched their children realize their mother's dreams. 'Be yourself' became the mantra of the next generation and 'sacrifice yourself' remained the mantra of their own generation.

**But what about their own emotions, their ambitions, and their dreams?** Education showed them what they could achieve but society set the parameters of their lives. They went through college and an occasional professional course – mechanically - knowing that marriage was the goalpost. The few who considered following a career found that their growth was limited. Any ambitions to do anything different were nipped in the bud by anxious parents and by traditional in-laws.

Today as these women reach old age and their children have grown up and moved into their own homes - the aimlessness of their lives has become a sore point. Their mothers lived within the confines of their homes and families, quite happily, with few sounds of protests. Their daughters (with encouragement from their mothers) had moved into careers or professional courses and were beginning to seek out lives of their own. But sandwiched between them were these ladies - educated, savvy, and intelligent with no place to use their knowledge and expertise.

Where do they stand today? "Aimless and drifting between family and home?" There will be many who will disagree with this statement - but look around you in the metropolises of India. How many middle aged and older women can today claim to have led a fulfilling, individual existence? As mothers, as wives, as housekeepers, as daughters-in-law they have surpassed themselves - but as individual entities - there exists an unanswered question.

Where do we (since I too am one of them) go from here? Today, we have entered the evenings of our lives - some contented and happy, others wondering about their faint sense of unease - of unfulfilled dreams and lost ambitions. While some have begun to seek fulfillment in avenues such as social work and 'good causes'; others have sought refuge in active social lives.

But do not mistake this sense of disquietude for despondency. We have realized that we are the bulwark of our families. We take credit for their successes - form their backbones when they need support - and provide experienced shoulders when they need something to cry on. We stand proudly and elegantly in society, respected, and loved by our families, but with a faint sense of unease and unfulfilled dreams.



## **VVWA INITIATIVES**

We had looked forward to a meaningful, interactive discussion during the open session of our recent Annual General Body Meeting. Unfortunately the Agenda took much longer than anticipated, and there was no time left to hold the open session. We had hoped to receive suggestions, complaints, issues etc., and have an interactive session. So, we thought it best to briefly mention the work that we have now taken up.

#### A) PRUNING:

Vasant Vihar has approximately 7000 trees. We receive half a dozen requests daily to carry out pruning of trees. We had taken up the matter with MCD. Unfortunately, they do not have the means or the capability to do so. Since, it is necessary to prune the trees and serve our members, VVWA has, therefore, decided to utilise a portion of the subscription money, that we collect in carrying out this pruning. We have hired a Skylift and have had discussions with MCD regarding disposal of green waste. The Managing Committee has also met post AGM and has sanctioned necessary funds to carry out this exercise. We expect this work will be completed in the forthcoming 2-3 months.



#### **B) BACKLANE LIGHTS:**

We have taken up the matter strongly with MCD and have furnished them with a list of lights that do not function in our backlanes. We are now pursuing them to rectify the lights. Wherever light fittings are required and MCD does not have them, we shall organise the same.

#### C) ENCROACHMENTS:

Everyday, more and more encroachments and illegal vendors are occupying our markets and pavements. We have closely followed the matter with MCD and the Police but no action has been taken. It is, therefore, necessary for us to initiate some action on our part.

It is proposed to appoint 12 Marshals (two for each block) to work everyday from 12.00 noon to 8.00 p.m. to patrol our markets and streets to see that encroachments are sharply reduced. We are taking up the matter with the SHO and thereafter the DCP for necessary approval. Once the Managing Committee approves this in principle, we will take up the matter for final approval and sanction.

#### D) CCTV CAMERAS:

Delhi Police has finally been able to get administrative approval for the installation of 57 advanced cameras at our intersections. The problem of funding remains. Delhi Police has requested the MLA to sanction the funds, which can now happen since the Municipal elections are over. In case, there is a problem VVWA has offered to step in and help with getting the funding organised.

#### E) BACKLANE TILING:

We have been able to secure funding from the MLA fund worth approximately Rs. 1.6 crores for 13 backlanes tiling. Estimates for another 13 backlanes tiling worth a sum of another Rs.1.6 crores have been sent by the MLA to the Government for approval. While we are confident of this, further action can only be taken once the new MCD takes charge.

#### F) WASTE MANAGEMENT:

This is possibly the most critical issue confronting us today. Closure of Dhalaos is a top priority. However, for this to happen we need to start segregation of waste on a very large scale. We are in consultation with experts, and very soon we will release a comprehensive document on the subject.

I would like to end here with the hope that by the next year will see substantial progress in our projects.
